Rev. Scott Trevithick, Moderator called the Presbytery to order on Tuesday, September 13, 2022, 1:00 pm. Pacific with an Opening Prayer

The moderator read from the Book of Order on The Calling of the Church (F1.03): "The Church is the body of Christ. Christ gives to the Church all the gifts necessary to be his body. The Church strives to demonstrate these gifts in its life as a community in the world (1 Cor. 12:27–28)." - 1. Rene Myers, Mission Engagement Advisor, thanks the Presbytery in a letter from April 18, 2022, for their donation of \$1,000 in March 2022 for the Matthew 25 fund (E052197)
- 2. I gave greetings on the Presbytery's behalf at the 20th-anniversary celebration at the First Thai-Lao on September 3 in Las Vegas with Director of Finance Vernon Manke.
- 3. A list of supply preachers for North and South areas of the Presbytery is available for downloading from the Presbytery email newsletter or the clerk. I list of those available to preach via Zoom is planned. Please contact the clerk to be included or excluded from these lists.
- 4. To achieve parity of teaching and ruling elders, I have balanced our 57 ministers of the word and

sacrament/teaching elders with our ruling elders (which include commissioned ruling elders) from our 23 churches. I plan to do so again in January and would appreciate suggestions from the Presbytery. A breakdown is Attachment A-4

- a. We have 57 Ministers of the Word and Sacrament (MOWAS) on the roll. Commissioners are allocated among the 23 churches according to size and request ranging from 1-4 commissioners. This totals 44 ruling elders. We have three members transferred to our roll since their church of membership no longer exists. We have 5 Commissioned Lay Pastors. We have 2 members that are leaders of worshipping communities. We have 1 each of a Certified Church Educator, Chairperson of a committee, and commissioner to the General Assembly who otherwise are not members of the Presbytery.
- b. A summary report with actual numbers is Attachment A-3 on the Presbytery meeting page on our website.
- 5. As required by the Constitution of the PCUSA, the Stated Clerk reports that the Presbytery has a manual of Administrative Operations, which can be found linked on the Presbytery website front page or at nevadapresbytery.org/manual.pdf It is also linked in the Presbytery emails.
- 6. As required by the Constitution of the Presbyterian Church (U.S.A.) the Stated Clerk reports that the Presbytery has established a policy on the Committee of Representation, which can be found in the Presbytery manual under Bylaws, 5.0600.
- 7. The Stated Clerk reports that the Presbytery's Safe Church Policy (covering sexual misconduct prevention and response) and Child and Youth Protection Policies **have not been enacted**.

9. The Stated Clerk reports that session minutes will be reviewed in person during this meeting and via other arrangements in October. The report of the results of the October 2021 review is in the clerk's report of the March minutes of the presbytery. We thank Elder Ray Bledsoe, our Assistant Records Review Clerk, for many years of service in Record Revies, reinventing the process so we could review records even during COVID quarantine.

- 10. As required by the Constitution of the PCUSA, the Stated Clerk reports the following annual minimum compensation for full-time ministers and CREs in the Presbytery is policy number 3 in our Manual of Administrative Operations:
 - a. The minimum compensation package for full-time clergy in the Presbytery of Nevada is; \$38,000 yearly salary, including housing and utilities, \$500 study leave, full pension, two (2) weeks study leave (study leave allowance and time to be cumulative up to a maximum of three years), four (4) week vacation, \$1,800 travel allowance (minimum, vouchered at the IRS rate)
- Reports the following names, Elder Elaine York and Elder Diane Chambers having been approved as the ordination exam readers for the year 2022.
- Statistics submitted to General Assembly, Available on the meeting page on our website at nevadapresbytery.org
 - Active membership reported 103 gains and 171 loses for a total of 2439 down from 2515 of which 1514 (62%) were women
 - 12 Baptisms, Average Weekly Attendance was 1103, 271 from Birth through Grade 12 were reported to be in Christian Education
 - Just under the half of the Presbytery was reported to be non-white
 - Annual reported income was just under 5 million dollars with expenses slightly less. Two thirds went to personnel, just over 1/5 went to facilities, and just under 10% went to mission.
- Our quorum, according to our by-laws, (3.0101) A quorum of a Presbytery meeting is three ministers of the Word and Sacrament who are members of the presbytery and three ruling elder commissioners from three different congregations.
- There were no commissions for ordination or installation.

- The Presbytery of Nevada APPROVED the Stated Clerk recommendation that the Presbytery grant permission to administer the Sacrament of the Lord's Supper to the following entities: Zephyr Point Presbyterian Conference Center, minister members of the Presbytery, and approved Commissioned Ruling Elders of the Presbytery when invited by the churches of the Presbytery and approved by the Committee On Ministry, in hospitals and other institutions, and hospice chaplains. In addition, THE PRESBYTERY APPROVED the Stated Clerk's recommendation that the celebration of the Sacrament of the Lord's Supper be approved for the in-person meetings of the presbytery, typically in March and September.
- The PRESBYTERY APPROVED that since the Elder Carl Dahlen, member of the Presbytery of Nevada, transferred his church membership to St. Andrews Presbyterian Church, Tucson, Arizona, on April 12, 2022. Based on 3.0204a, to delete his name from the Presbytery rolls.
 - This leaves three members of Presbytery who are not members of a Presbyterian congregation: Vernon Manke, Carol Manke, and Carol Sandmier.

Administrative Commission

The Administrative Commission to **Lee Vining** reports that it is continuing its work helping the church reorganize and asks for the Presbytery prayers for their ministry.

The Administrative Commission to **First Korean Presbyterian Las Vegas** reports it is continuing its work and asks the Presbytery for prayers for its ministry, the congregation and pastor.

GREETINGS Rev. Sara Tillema, Director of Programs, Zephyr Point Presbyterian Conf Center brought greetings from Zephyr Point Presbyterian Conference Center.

General Assembly Commissioner Reports

General Assembly Commissioners: Rev. Bob Kelley and Elder John Harbison reported on the procedures and actions of General Assembly. Rev. Bob Kelley was on the Moving Forward Committee and Elder John Harbison was on the Addressing Violence in the USA Committee. Voting on the Amendments will be early next year.

Synod Commissioners distributed their report at the meeting. It is Attachment A-6.

COMMITTEE REPORTS

Peace And Justice – Presentation by Rev. Timothy Son on "Engaging in the Ministry of Peace and Justice". Timothy is pastor of the Norwood Presbyterian Church in northern New Jersey, a congregation with a proud 153-year history. He is also the Liaison for Korean Church Relations with Princeton Theological Seminary.

Without objection, Presbytery paused for a break and reconvened at 3:45 pm Peace and Justice committee report continuing.

CP Linda Hamilton reported that the committee decided to donate \$1,000 PCUSA Korean Mission Co-workers Kurt Esslinger and Hyeyoung Lee Serving with the Presbyterian Church in the Republic of Korea (PROK), the National Council of Churches in Korea (NCCK), and the Presbyterian Church of Korea (PCK)

Mission Outreach – Udechukwunyere Chukwukelu, reported on the status of her worshipping community's work in church restoration in Nigeria.

Rev. Jeanie Shaw shared a video report of the Disaster Response Ministries mission trip to Metlakatla, Alaska, which some members of the Presbytery of Nevada attended and was supported by \$3,500 grant by the Presbytery of Nevada.

The Committee sought and received the approval to support these PCUSA missions through the Mission Personnel Support (E132192) account:

\$1000.00 to support PCUSA Mission Co-Worker John McCall serving in Taiwan. \$1000.00 to support PCUSA Mission Co-Worker Rev. Joseph Heikkila serving in Nigeria. \$500.00 to support the ministries of PCUSA Mission Co-Workers Cobbie and Dessa Palm and \$500.00 to support the ministries of Cathy Chang and Juan Lopez all serving in the Philippine's. \$1000.00 to support the ministry of the Presbyterian Co-Worker in Thailand \$5,000 to support Phoenix Food Pantry at Lake Tahoe Community Presbyterian Church \$8,000 to support Emmanual Faith Chapel with its ministries in Las Vegas and Nigeria.

It was Moved, Seconded and Approved that the committee's budget be increased an additional \$12,500 from unrestricted funds to cover these additional grants.

Equipping – Rev. Adrian Doll, Chair reported on use of budgeted funds by the committee.

- \$3000 of 2022 Block Grant to Youth Triennium Fund
- \$400 to support Linda Rauenbuehler, Director of Congregational Care at Green Valley, to attend the Presbyterian Older Adult Ministries Network (POAMN) retreat in Little Rock on October 7 and 8.
- \$1725 gift to support a women's retreat/workshop in October 7 & 8 at Mountain View.
- \$400 requested by Lake Tahoe Community Presbyterian Church to support their Blessing of the Animals event.
- \$500 requested by Adrian Doll to support the Southern Nevada Pastors Luncheon. (From the Program Development Fund)

There are funds available to fund events and ministries. Congregations are encouraged to apply. The committee is working on a single form that would apply for all sources of grants and funds available from the Presbytery as well as an orientation handbook for presbyters.

Nominating – Elder Brandolyn Thran, CP, Chair shared a video about serving in the Presbytery of Nevada. (Posted on the website.)

It was moved, second and approved that nominations be closed and those nominated by the committee be elected.

The Presbytery recessed at 5:15 pm with prayer by CP Chris Kirschman for dinner and worship.

Presbytery Reconvened on Wednesday, September 13, 2023 at 8:45 am with Prayer and Reflection from CP Linda Young, Hawthorne

Committee On Ministry – Rev. Jim Houston Hencken, Chair reported for the committee.

It was moved, seconded, and approved after discussion and to receive **Rev Craig Sanders** as a minister member in the Presbytery of Nevada. Craig is serving in a ministry role at Grace Presbyterian Church, Las Vegas. Prayers were offered the Rev. David Dandy, a former youth group member of Rev. Craig Sanders.

It was moved, seconded, and approved our committee report to pause the meeting to move our cars from the Lake Tahoe Community Presbyterian Church's parking lot in order to make room for those coming to get provisions from the Phoenix Foos Pantry.

The presbyters moved their cars.

It was moved, seconded, and approved to remove from the table the Committee on Ministry's report and resume our meeting.

It was moved, seconded, and approved to recognize the vows which the **Rev Shin Hwang** of First Korean Presbyterian Church, Las Vegas, has taken and his ministry service as evidence which qualifies him for ordination.

Rev Hwang was asked and answered in the affirmative the Constitutional questions of ordination and laying on of hands prayer was offered and a handmade red ordination stole was given to him.

The Presbytery of Nevada, in consultation with the session or another responsible committee, **approved** its determination that its strategy for mission requires the authorization of **Vicki Wilson**, a ruling elder, to be commissioned to limited pastoral service at Christ Presbyterian Church, Gardnerville, a validated ministry of the Presbytery of Nevada beginning on October 1, 2022.

The Commissioned Ruling Elder named above is authorized to preach the gospel, lead worship, pray with and for the people, teach and conduct Bible studies, provide pastoral and spiritual

care, moderate the session of the congregation named above, and as moderator, install and ordain officers of that congregation, and administer the Sacraments of Baptism and Communion as authorized by the Session of the congregation named above. This commission is valid for three years. This Presbytery will review this commission every year.

Vickie Wilson was asked and answered in the affirmative the Constitutional questions and laying on of hands prayer was offered.

It was moved, seconded, and approved that Inquirer **Kimberly Mendoza** to be moved to Candidacy. Laying on of hands prayer was offered by Pastor Nonong of the Presbyterian Church of the Living God.

It was moved, seconded, and approved to receive **Rev Tom Willadsen** as a Minister Member of the Presbytery of Nevada. Tom is serving as the Transitional Pastor to the church at Spanish Springs, Sparks.

It was moved, seconded, and approved that all future Commissioned Pastors (CP) be commissioned with the following statement: this commission includes permission to preside over the sacraments, weddings, funerals and may moderate session and congregational meetings at any congregation within the Presbytery of Nevada at the request of the church's session and with the approval of the chair of the Committee on Ministry.

It was moved, seconded, and approved that all future CP's be commissioned with the following statement: this commission includes permission to preside over the sacraments, weddings, funerals and to moderate session at any congregation within the Presbytery of Nevada at the request of the church's session and congregational meetings with the approval of the chair of the committee on ministry

Trustees Elder Scott Plummer, Chair Elder Vern Manke, Director of Finance

The trustees inform the Presbytery that

- it has granted St. John's PC, Reno \$10,000 for parking lot work & lighting with some safety issues, the request is ATTACHMENT C-1.
- It continues financial support of First Korean Presbyterian Church, Las Vegas after relocating the church and selling the building. The support is based on the anticipation

of the proceeds of the building sale which are not due until the end of 2025, when reconciliation with the church will be undertaken.

- It was moved, seconded, and approved that Presbytery give permission to the Community Presbyterian Church's Session at Lee Vining, CA to rent out the Manse. Rental income shall be assigned to the Community Presbyterian Church of Lee Vining. This is not a permanent change in use.
- The trustee reported they had authorized funds to make repairs necessary up to \$10,000.
- It was announced that last night's offering for Ukraine ministry currently totals \$1,540.
- It was moved, seconded, and approved to approve the 2023 Budget Attachment C-5.

Personnel – Rev. Scott Trevithick

It was moved, seconded, and approved to update the Job Description for the Stated Clerk/General Presbyter (SC/GP). Included in these minutes as Attachment B-3.

It was moved, seconded, and approved for the renewal of the Stated Clerk/General Presbytery employment for three year additional term from April 1, 2023 - March 31, 2026. This recommendation was based on review of the SC/GP in March 2022, feedback from the SC/GP, and committee discussion,

It was moved, seconded, and approved upon request of the Stated Clerk/General Presbyter and the Presbytery Pastor, that their entire compensation be designated as Housing Allowance.

Meeting Task Force

Rev. Scott Trevithick presented a two-part proposal from the Meeting Task Force that included an in-person meeting in the fall of each year at Zephyr Point Presbyterian Conference Center and at minimum, one online meeting per year.

The presbytery did **not** approve the proposal.

Without objection, the Meeting Task Force commission was dismissed with thanks.

Installation All newly elected officers and Chairs of Committees were invited forward, and prayer was offered by Rev Kate Freeman, Presbytery Pastor, over them in thanks for their service and asking for God's empowerment thereof.

Resolution Of Thanks – Rev. Jim Houston-Hencken, Grace PC, Las Vegas thanked all those who made the Presbytery.

Closing Prayer – Elder Peggy Hall, Spanish Springs

The Presbytery adjourned at noon.

CLERK'S REPORT

Recognition of Native Lands and Peoples:

The Presbytery of Nevada is comprised of land that was faithfully stewarded by indigenous people for countless generations. Today we specifically acknowledge and thank THE WASHO (WASHOE) From an article by Judy DePuy of the **Truckee-Donner Historical Society** used with the author's permission

The Washo tribe inhabited the Lake Tahoe region over 1300 years ago. They would generally spend the summer in the Sierra Nevada then in the fall move to the mountain ranges to the east, utilizing the valleys found in between for the winter and spring. The western part of the Washo territory was in the mountains and subject to heavy snows so few people wintered there.

Washo people were semi-sedentary hunters and gatherers and very knowledgeable about their land and its resources. This included an understanding of the seasonal cycles of both plants and animals. Fishing was a huge part of the Washo way of life and each family had their own fishing grounds.

The Washo did not have sustained contact with white Euro-Americans until the 1848 California Gold Rush. Their resistance to incursions on their lands proved unsuccessful. The last armed conflict with the Washo and non-Indians was the Potato War of 1857 where starving Washos were killed for gathering potatoes from a settler's farm.

Their hunting grounds were lost to farms and the pinon pine groves fell to feed Virginia City's demand for lumber and charcoal. Commercial fishing at Lake Tahoe destroyed another important resource to the people. These events forced the Washos to depend on jobs found on ranches, farms and in cities.

The Lake Tahoe area is a very spiritual place for members of the Washo Tribe. It also explains their concern for the protection of locations important to the Washo Heritage.

CHIEF TRUCKEE'S INFLUENCE

No story on Truckee's Native American influence would be complete without a nod to Chief Truckee. There are many stories on who first called him "Truckee" but all of them agree on his friendship with the early explorers and settlers.

One such story talks about a Paiute chief who in 1844 told members of the Stephens-Townsend-Murphy party that 50 or 60 miles to the west there was a river that flowed easterly from the mountains and along the river they would find large trees and good grass. A scouting party (which included Stephens, Caleb Greenwood and the chief) rode out to investigate. While exploring, their guide used the Paiute word for "all right". The word sounded like "tro-kay" and everyone thought the

chief was telling them his name. The scouting party found the route to be "all right" and began to refer to their guide as "Chief Truckee" (a liberal translation of "tro-kay"). The chief liked the name so much that he retained it for the rest of his life. - Judy DePuy, Truckee-Donner Historical Society

We honor the Indigenous people's ongoing work for recognition and their fight to recover their relationship with the land. Repudiation of the Doctrine of Discovery and encouragement to start our meetings with a land acknowledgment was recommended by the PCUSA General Assembly in 2018 to all mid councils, that is presbyteries and synods. It is a way to demonstrate that we are God's people who stand for justice for all.

Wherever you are, I encourage you to learn about the indigenous people of the land that you are on.

- I gave greetings on the Presbytery's behalf at the 20th-anniversary celebration at the First Thai-Lao on September 3 in Las Vegas with Director of Finance, Vernon Manke.
- A list of supply preachers for North and South areas of the Presbytery is available for downloading from the presbytery email newsletter or from the clerk. I list of those available to preach via Zoom is planned. Please contact the clerk to be included or excluded from these lists.

Synod of the Pacific - Take Home Piece

124th Stated Assembly Zoom Video Conference May 4-6, 2022

The following notes are for commissioners' own use and for reporting to presbyteries. They are not official minutes.

- The assembly began on Wednesday evening with a Vespers service led by the Moderator, Kaye
 Whitney. [Kaye and about a quarter of the commissioners were together at Zephyr Point Presbyterian
 Conference Center and reported that it was grand to enjoy in-person fellowship. Worship, plenaries,
 and committee meetings were conducted on Zoom.] Worship included the 2021 Necrology report, a
 longer-than-usual list this year. Synod received an offering of \$3750 designated to Presbyterian
 Disaster Assistance for the benefit of Ukrainian Refugees.
- During staff reports on Thursday, Synod Executive, Nancy Martin Vincent (MWS, SFR), highlighted the Hilda V. Thompson grant fund, which can be used for mental health needs, especially in these days of COVID. Nancy reported on staffing changes in San Joaquin and Boise presbyteries, along with ongoing conversations of a task force developing long term strategy with Eastern Oregon, Boise, and Kendall presbyteries. Also, Nancy reported that plans are on track for the Synod office to move at the end of 2022.
- Synod Director of Business Services, Brian Burns, thanked staff for their ongoing work, ensuring that
 the services provided by the Synod have continued to flourish throughout the pandemic. Brian
 reported that the Synod had a 'clean' audit for 2021 and that budgets for 2023 will be presented by
 the Mission Finance Committee later in the meeting.
- 4. Synod Stated Clerk, Katherine J. Runyeon (MWS, SFR), presented a series of "Understanding Per Capita" videos that highlight "connectionalism" throughout the denomination. All can be found here: https://percapitaunification.org/interpretive-videos. Before recess on Thursday, Kathy led participants, using a prayer she had been invited to write for a national gathering of mid council leaders. The Stated Clerk's report on Friday included a variety of articles and PCUSA news all available on the Google drive for this meeting.
- Guest speaker, Jim Rissler, President and Chief Executive Officer of the Presbyterian Investment & Loan Program (PILP), provided an extensive and helpful presentation of PILP's ministries and programs. He reported where PILP and Synod have collaborated to provided joint loans and indicated openness to working together on other projects.
- During committee reports on Friday, the 2023 budgets were approved with few changes from the current year. The Synod per capita apportionment remains at \$5.22.
- Interim Committee on Representation Chair, Jeffrey Joe (RE, KEN), offered both visual and written expressions of diversity of his own: several paintings and a poem he wrote titled, "A Hope's Chance".
- Appreciation was expressed to chairs and commissioners who finish their terms when we convene in October – with an invitation for commissioners to talk with presbyteries about being re-elected!
- Synod next meets on October 5-7, 2022, by Zoom with the possibility of an in-person option, if safe.
 2023 meetings are scheduled for May 3-5 and October 4-6.



The Summary of the 2022 General Assembly in English, Korean, and Spanish from the *Presbytery Outlook* was purchased for the commissioners at this meeting and was distributed.

Our By-laws provide that "The Council shall have all the authority as permitted by the Book of Order and consistent with Presbytery Policy, that is, to act with the full authority of Presbytery between Presbytery Meetings" Our by-laws are in the Manual of Administrative Operations on the front page of nevadapresbytery.org website

Approved the following as the officers for the Presbytery of Nevada: President, Scott Plummer; Secretary and Resident Agent, John Christy Ramsey; Treasurer, Vernon W. Manke; Director, Lynne Zenier; Director, Robert C. Kelley.

Appointed a special committee to address Presbytery Policy #5, Travel, to adjust it to be fair and equitable. Committee to consist of Scott Trevithick, Christy Ramsey, and Vern Manke. The committee to report back no later than the September Presbytery meeting Sept. 12-14, 2022.

Replaced Helen Hutchinson with Elder Elaine York as Ordination Exam Reader.

Appointed an Administrative Commission to assume original jurisdiction of the session of Lee Vining Presbyterian Church. The Administrative Commission be charged with the following actions/responsibilities:

- Act as the session of Lee Vining Presbyterian Church until such time as a session is duly elected (See #3);
- Receive the resignation of the Reverend Rebecca Watkins (thereby dissolving the pastoral relationship, see Book of Order G-2.0902);
- Work with identified leaders to determine a time to hold a congregational meeting at which elders can be elected and a session constituted (see G-1.0503);
- Meet with the congregation to determine the vision and future of the Lee Vining church, and, if desired by the session, engage in steps 5, 6, and 7;
- Form an interim/temporary supply pastor search committee and or delegate this responsibility to the newly-elected session,
- Ensure the congregation of Lee Vining is properly instituted as a church in the State of California with elected and serving corporate officers, and,
- Ensure that pulpit supply is being provided for weekly worship until such time as this responsibility can be delegated to the newly elected session.

Updated milage rates and updated and restored the deleted meal allowances. Milage is paid at fifty (50) cents a mile and meal allowances are 18 for breakfast, 18 for lunch, and 38 for dinner. The policy is in the Manual of Administrative Operations and is attachment B-2

PRESBYTERY OF NEVADA, PCUSA¹ JOB DESCRIPTION

TITLE: Stated Clerk/General Presbyter

STATUS: Salaried, Exempt

Presbytery of Nevada

PURPOSE: The Stated Clerk/General Presbyter (SC/GP) is an officer of the presbytery, as required by the Book of Order, with judicial and ecclesiastical/administrative duties.

> As Stated Clerk, the SC/GP is responsible for recording and maintaining records of all Presbytery transactions, preserving records, keeping rolls of membership and attendance, implementation of pertinent governing body decisions, and functions specified in the Presbytery Administrative Manual.

As General Presbyter, the SC/GP is responsible to assist the Committee on Ministry as requested, participate in the Synod and General Assembly Executive Forum and training, make and receive executive reference checks on behalf of the Presbytery and the Congregational PNC

ACCOUNTABILITY: The Stated Clerk/General Presbyter is elected by presbytery on nomination of the Personnel Committee. The SC/GP is employed by the Presbytery of Nevada, supervised by the Council through Personnel Committee.

REPORTS TO: Presbytery of Nevada directly and through its Council.

JOB RESPONSIBILITIES AND TASKS:

I. Function: Rolls, Records, and Reports

A. Tasks

- 1. Process and record teaching elder calls, changes in terms of call, contracts, dissolutions, transfers, dismissals, and renunciations.
- 2. Prepare and/or receive, maintain, provide for safekeeping and/or distribution of minutes of the Presbytery, corporate papers, annual reports, reports to and from other governing bodies, and other historical documents pertinent to the life and history of the Presbytery.
- Maintain the following rolls:
 - a. Membership rolls: teaching elders, ruling elders, commissioners
 - i. and members, corresponding members, pastors of new church
 - ii. developments, and Commissioned Ruling Elders
 - b. Attendance at Presbytery meetings which shall be intentionally
 - provided to the Nominating Committee and used in their recommendations
 - c. Former commissioners and Youth Advocate Advisory Delegates to the General Assembly and delegates to Synod, as well as rosters of church rotation for such commissioners. YAAD's and delegates,
 - d. Candidates and inquirers

Note: The Personnel Committee proposed a revision of the position description to incorporate tasks related to the General Presbyter role. The revision was approved by the presbytery 9/14/2022.

- Roster and terms of current and former members of the Presbytery's Permanent Judicial Commission for the past eight (8) years
- 5. Agencies with formal relationship to the Presbytery
- 6. Churches, agencies, and special ministries of the Presbytery
- Prepare and distribute current membership directories annually, including teaching elders, ruling elder commissioners, churches
 - a. and their officers, councils, committees, and entities of the
 - b. Presbytery
- 8. Oversee and secure Presbytery and congregational statistical reports to
 - a. the General Assembly and Synod annually
- Maintain the Presbytery reporting concerning ministries and pastors in transitions on the Church Leadership Connection
- Assist PNC of congregations and session search committees in the seeking Pastoral leadership
- 11. Oversee and maintain the online assets of the Presbytery Website directing the Presbytery webspinner in its content, security and function

II. Function: Correspondence and Notices

A. Tasks

 Receive, process, and report Presbytery correspondence received from higher more inclusive governing bodies.

III. Function: Meetings of the Presbytery

A. Tasks

- Procure adequate facilities for stated and special meetings of the Presbytery, Council, and Trustees and, when required, committees and/or commissions staffed by the SC/GP
- In consultation with the Moderator and designated members of the Council, prepare a proposed docket for all stated and special meetings of the Presbytery and Council meetings
- Issue notice of all stated and special meetings of the Presbytery at least ten (10) days in advance, in accordance with Robert's Rules of Order, to the Presbytery membership and Clerks of Sessions
- 4. Ensure the availability of the following documents and resources to be present at the Presbytery meetings: minutes of the Presbytery for the previous two years, a copy of the Book of Order, the Presbytery Administrative Manual, Robert's Rules of Order, Newly Revised, and the minutes of the most recent Synod of the Pacific meeting
- Assist the Presbytery's Moderator during Presbytery meetings; determine and inform the Moderator of a quorum
- Provide for and communicate to the body a parliamentarian to serve during stated and special meetings
- Prepare and delivers an annual necrology report to the Presbytery, Synod, and General
 Assembly annually and receive requests of all overtures and memorials to be addressed at the
 stated meeting by the Presbytery Pastor and resource the Presbytery Pastor when requested
- Oversee the election of commissioners, delegates, and a YAAD during the Fall Presbytery meeting
- Serve as Clerk for meetings of Council, which includes securing a venue, preparation of the docket, notice of meeting, and minutes
- 10. Attend and resource the Committee on Ministry with voice but without vote.

IV. Provide Resource and/or Counsel

A. Task / Shall Respond to:

- Ruling and teaching elders of the Presbytery, Presbytery officers, committee, and commission
 members regarding the Constitution of the Presbyterian Church (U.S.A.), the Presbytery
 Administrative Manual and Robert's Rules of Order; assist presbyters in understanding policies
 and actions of the Presbytery and its councils, committees, and commissions, as requested
- The Committee on Bills and Overtures, the Permanent Judicial Commission, the Committee on Ministry, and administrative committees and commissions established by the Presbytery
- The individual appointed by Equipping Ministries to conduct orientation of new ruling elder commissioners and teaching elders to familiarize presbyters with the Presbytery's structure and enable full participation in Presbytery meetings, preparing and providing appropriate orientation materials as needed
- 4. Assure the Journal Clerk is supported by appropriate technology at Presbytery meeting venues
- Provide supervision and resource annual Presbytery Records Review of Clerks of Session, usually coordinated with semi-annual Presbytery meetings
- Provide training and support to Clerks of Session to ensure full understanding of their responsibility to comply with the requirements of the Presbytery and Book of Order
- 7. PNCs and sessions seeking pastoral leadership
- 8. Presbytery's Permanent Judicial Commission and other Judicial Commissions
- Should a disciplinary case be filed, the SC/GP will be granted additional compensation based on the additional time required to train and resource the committee and process the proceedings.

Dear Vern,

St John's in Reno is embarking on a very large and much needed maintenance effort to improve the safety of attending services and functions at our church.

As you may be aware, we are a congregation of older adults. Our parking lot has deteriorated so that we have had several falls. Also, our outdoor lighting is inadequate for safe evening meetings. We are known for quality organ recitals and host many evening events.

Therefore, our Building & Grounds Committee has recommended we move promptly to remedy these safety concerns. First, they recommend upgrading our parking lot lighting. Based on bids, the cost of that project will be about \$100,000. Second, we would have the parking lot crushed and repayed at a bid of about \$200,000.

After obtaining Congregational approval, the Finance Committee believes that it can repurpose approximately \$200,000 in unspent funds to these urgently needed projects. This leave about a \$100,000 shortfall.

We are therefore asking if Presbytery would consider a grant of \$100,000 for these projects, or whatever size grant that would be available.
