#### A. Clerk's Report

- 3. Suggestion that approval of Presbytery minutes be done at Presbytery meetings.
- 4. Policy Review
  - a. Policies 4, 12, and 15 were reviewed without changes and Policies 2 and 3 were revised on this date
    - a. Policy 2 Study Leave. Motion: To remove all words from line items #3 (Study leave should not be used as a vacation, where the purpose is physical and mental refreshment, but as enrichment for ministry) and #5 (The COM at its triennial consultation with the Minister and Session, shall include a discussion on study leave taken and planned.) from Policy 2 and renumber the current item #4 as item #3. Carried
    - Policy 3 Minimum Salary. Motion: to add the words "full time" prior to the word "clergy" in the first line so it now reads: "The minimum compensation package for full time clergy in the Presbytery of Nevada is..." Carried
- 5. General Assembly (GA)
  - a. We are in need of a GA Commissioner. GA Plenary will meet on Zoom prior to and after the Committees meetings which will be staggered over five days and in-person in Louisville, KY.
  - b. Referred to Brandolyn, as current moderator of Nominating Committee (NomCom). Rev Sue Taylor, past moderator of NomCom is aware.
- Congregations Record Review Graciously performed by Elder Ray Bledsoe (list in Clerk's Report)

- 7. There was one "email" vote performed by Council since the last meeting.
- 8. Planning Center is a new online data base which can be used by committees and to post resources which are not on the website which are open to public viewing. For further information contact Christy.
- 9. Stated clerk raised question concerning influx of "Job opportunities" emails outside of the PC(USA) job center (CLC) and was guided to ignore these.

## B. Presbytery Meeting Task Force – Rev Scott Trevithick

Scott reviewed the scope of the Task Force indicating they had met in November, December, January and will met once more prior to our March Presbytery Meeting in Las Vegas. The hope is to enhance both modes of meeting: online and in person. Worship, relationship building, fellowship, self-care, and recreation are all being discussed. For example, to include afternoon options of relaxation, creative activities, led nature/reflection hikes around the Tahoe Basin. Task Force is considering costs of travel, lodging, meeting space in both the North and South parts of the state. A feedback tool is being developed for our March Presbytery Meeting and the Task Force will present its recommendations at the Fall 2022 meeting.

## C. Committee Reports

- 1. Trustees Scott Plummer
  - a. Elder Scott Plummer was elected Chair for 2022
  - b. First Korean Presbyterian Church (FKPC) removed the time deadline for the grant and renewed the lease with UCC church Abundant Peace Church.
  - c. Renting old FKPC building for \$2250./month and negotiating with UCC Abundant Peace Church as regards repairs.
  - d. Vern's financial reports were presented but acknowledged as incomplete. Final ones due at March meeting. **Motion**: to approve budget overruns. **Carried**
  - e. KENCO FUND. **Motion:** Trustees and Council authorize forwarding the proceeds of the Kenco Fund for 2022 to First Presbyterian Church of Bishop, CA, with the stipulation that the church provides an accounting of how funds are used in compliance with the agreement with the Presbyterian Foundation. **Carried**

## 2. Personnel – Scott Trevithick

- a. Scott has sent reflection questions for self-evaluation to the staff of the Presbytery. And hopes to hear from other members of the Personnel Committee. Adrian Doll offered that Diane Schorr is unable to serve at this time.
- b. Christy raised the idea of how Committee chairs are selected. Motion: To direct the Stated Clerk to present language changes to Policy 20 in order to allow for the Nominating Committee to select a convener to get committees started. Carried
- 3. Mission Outreach Pat Mecham

- 4. Committee on Ministry Adrian Doll
  - a. Raised the question of how committee votes should be handled. Motion: to strike the word Committees from Policy 17 as follows: "The Presbytery Council and Committees, may take e-mail votes on business items..." Carried
  - b. Report that Rev Mariano Ordonez (Nonong) of Presbyterian Church of the Living God has agreed to serve as Temporary Supply Pastor to the Henderson Presbyterian Church following Rev Lee Styer's retirement on Dec 31, 2021. This is seen as a good solution and opportunity for both congregations.

- c. Motion: AS of 01/01/2022 Brandolyn Thran, CLP, will now be serving at Wells Presbyterian Church with the authority to perform the sacraments of communion and baptism. She is not authorized to do weddings. Her CLP relationship with the Elko church has been dissolved.
- d. Report that Rev Dana Pope has been moved to Member-at-Large upon her move to San Antonio, TX.
- e. Report that COM has approved Rev Christy Ramsey's Ministry to Valley Church in Bishop in order to provide funds for his travel and lodging
- f. Report that COM approved Chris Kirschmann of Mountain View Presbyterian Church as a Commissioned Lay Pastor (CLP). He will be examined on the floor of the Presbytery.
- g. Report that COM approved the term extension of an elder at Virginia City's First Presbyterian Church due to reduced attendance and Covid-10 circumstances.

An electronic vote by the Presbytery Council provided by Policy #17 of the Presbytery of Nevada was conducted between 9-18-2021 and 9-22-2021

14 members of the Council of the Presbytery of Nevada were emailed. All voted via an online survey hosted at MailChimp via an individual link sent only to their email and additionally entered their name on the survey. There are 11 voting members. All members opened the email and responded online during the voting period. There were no motions to table the vote.

The motion was:

"Shall the Presbytery of Nevada approve the addresses and listing of officers and agents (linked here and emailed previously) to be filed as a Religious Non-Profit with the state of California?"

Of 11 council members, the vote was 11 YES, 0 No, 0 members not voting, 3 non-voting members indicated their receipt of the email vote survey.
