A stay at Zephyr Point is always a treat, but it is especially meaningful when shared with sisters and brothers in the faith, gathered to further the work of Christ's Church.

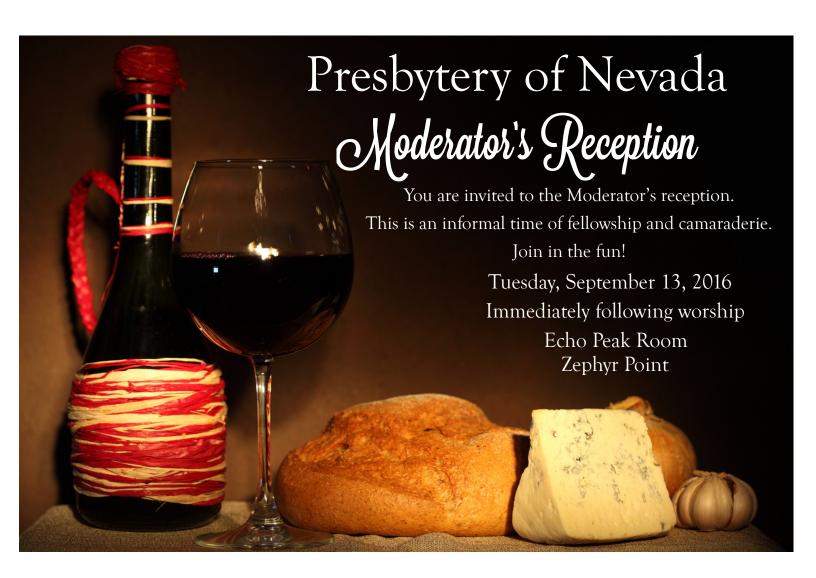
