

**MINUTES OF A STATED MEETING OF THE PRESBYTERY OF NEVADA**

Council **VOTED** on March 30, 2015 to **APPROVE** the request from the Moderator, Rev. Rebecca Watkins, that Ruling Elder Melva O'Neil as Chair of the Committee on Ministry for one (1) year;

Council **VOTED** on August 3, 2015 to **APPROVE** the request from the Stated Clerk to dismiss Rev. Dr. Thomas J. Baughman, HR, effective, July 21, 2015.

Council **VOTED** on June 29, 2015 to **APPROVE** the recommendation from the Moderator of Trustees authorizing the President of the Corporation (Ruling Elder Wayne Petersen) to sign all required documents to execute the agreement between GVPC/Presbytery of Nevada and Sprint, and the transfer of the cash flows to the finance company.

COUNCIL REPORT (Actions Only), Fall 2015 Presbytery

- (1) VOTED on and APPROVED the Clerk's Report;
- (2) VOTED on and APPROVED that the job description for the Presbytery Pastor be presented at the Fall Presbytery meeting;
- (3) VOTED on and APPROVED the recommendation from Trustees to give the churches in the Nevada Presbytery a gift of \$1,000;
- (4) VOTED on and APPROVED the above mentioned \$1,000 gift be extended to NCD's as well as churches, totaling \$24,000;
- (5) VOTED on and APPROVED the request from Ruling Elder Bedford Holmes, Executive Director of Zephyr Point Presbyterian Conference Center (ZPPCC), that the Presbytery of Nevada enter into

a three (3) year commitment with ZPPCC to host its Fall Presbytery Meetings exclusively at ZPPC and that the designation be renewable after the three year commitment;

- (6) VOTED on and APPROVED the recommendation from the Stated Clerk that the current Chair of Nominating, Ruling Elder Lynne Zenier, be extended for one year (Class of 2016);
- (7) VOTED on and APPROVED the recommendation from Trustees that Presbytery pay \$1317 per month from June 2015 to December 2015, totaling \$9,219 bringing the PILP loan for First Korean, Las Vegas up to date;
- (8) VOTED and APPROVED the recommendation from Trustees that Henderson Presbyterian Church be given a grant of \$5,000 to be used toward updating its media equipment in the Sanctuary;
- (9) VOTED and APPROVED the recommendation that all reasonable expenses submitted by receipts for travel and lodging for the Missionary speaker, Rev. Dr. Barry Dawson, be paid by Presbytery;
- (10) VOTED and APPROVED the recommendation from Trustees that the Stated Clerk be allowed up to \$1,000 to replace her laptop lost while traveling;
- (11) VOTED and APPROVED the recommendation from Trustees that the Chair of Trustees and the Stated Clerk sign the \$5,000,000 line of credit with Umpqua Bank, per the request of the Synod of the Pacific;
- (12) VOTED and APPROVED the request from Trustees that the Stated Clerk initiate paperwork with the Secretary of State to remove the previous Stated Clerk as Resident Agent and appoint the current Stated Clerk as Resident Agent for The Presbytery of Nevada, Incorporated;
- (13) VOTED and APPROVED the request from Trustees that the Presbytery of Nevada be listed on the University of Nevada, Reno Foundation Court of Honor in recognition of its donation of the Spanish Springs NCD property.

## **COMMITTEE REPORTS**

### **1. EQUIPPING – Ruling Elder Lyla Dusing**

Presbyters were updated on the status of the Religious Alliance in Nevada lobbying activities by RE Allan Smith, Environmental Ministry issues by RE Elaine Noble and the Pastors luncheons in the North and South by Chair Dusing.

Grants were awarded to two programs: Campus Pizza, Rev. Pat Mecham, Elko First, Elko NV for \$1,100.00 and the Older Adult Ministry Program, St. John's Church, Reno, NV for \$1,200.00.

The committee approved RE Renee Kelley as Trienium Registrar.

The committee is revising the committee responsibilities which will be presented to Council.

The committee reported it will not be taking any action on the Georgia Foothills Overtures.

The committee will make a decision on the Fossil Fuel Overture after the period of comment (input from Presbyters) ends on November 1, 2015 and inform Council.

2. Mission Outreach – Ruling Elder Scott Plummer  
Presbyters were updated on the work of the committee. Chair Plummer commended the committee for its work on New Church Development, support of food pantries and Amazing Grace Ministries.

New Church Developments Updates: First Filipino-American, Las Vegas, NV is growing and thriving. Valley Church in Mesquite, NV has called Adolph Kunen as its Pastor beginning October 1, 2015.

Charter of First Thai-Laotian: September 6, 2015, five churches came together to charter the church. It was an uplifting and eclectic ceremony. The Presbytery VOTED and APPROVED the dissolution of the Administrative Commission for Chartering First Thai-Laotian with great gratitude.

## **NEVADA PRESBYTERY STATED MEETING**

**September 16, 2015**

**Zephyr Point Presbyterian Conference Center, Zephyr Cove, NV**

Presbytery reconvened at 8:30 a.m., on Wednesday, September 17, 2014. Reverend Pat Mecham, First Presbyterian Church, Elko, NV gave an inspiring worship service. Rev. Mecham led us in prayer.

Announcement: Ruling Elder Vern Manke announced that the offering collected at the worship service for First Thai-Laotian totaled \$1,490.00.

## **CONTINUATION OF COMMITTEE REPORTS:**

3. SYNOD COMMISSIONERS – Rev. Pat Mecham, Rev. Hilda Pecoraro, Ruling Elder Art Ritter and Ruling Elder Elaine Noble.

Reports were given on the recent Synod meeting held in Reno, NV. Of particular interest was the personnel report extending the Transitional Synod Executive Jane Odell and the Transitional Stated Clerk John Kelso through November 2016. Both Rev. Mecham and RE Elaine Noble were elected as new commissioners. Rev. Pat Mecham was elected as Vice Moderator and Moderator Elect of the Synod.

Presbyters were advised of the opportunity to serve on a GA Committee. Currently, there are 18 people in our Synod serving on such committees but none from Nevada. Interested individuals may contact Rev. Hilda Pecoraro. Presbyters were also made aware of opportunities to serve on Synod and of the Dream Loan from Synod (currently at 3%). Additionally, there are 3 year Opportunity grants for missions and ministries that benefit more than one entity, 2 year Hilda Thompson Medical Ministries grants and 1 year Emerging Needs Grants.

4. **PERSONNEL** – Reverend Dana Pope

The committee voted and approved, by email, the appointment of Rev. Christy Ramsey as Journal Clerk for the Fall Presbytery meeting. A permanent Journal Clerk is needed (someone who is willing to attend all Presbytery meetings, expenses will be paid).

The committee received and accepted the resignation of Nevada Presbytery Stated Clerk, Joan Jeffers, with regret and prayers. An exit interview was conducted and the committee expressed their deep gratitude for her service, as well as their best wishes and God's blessings for the future. The committee discussed methods of recruiting.

Stated Clerk Actions: The committee approved the revised Stated Clerk job description as a working document [*see attachment A*]. The committee approved increasing the yearly salary for the Stated Clerk up to \$20,000 for 20 hours/week beginning October 1, 2015.

Presbytery Pastor Actions: The committee approved the position of Presbytery Pastor as a half-time contracted position, up to \$20,000 a year with expenses and mileage reimbursed at current IRS rates up to \$5,000 yr.

5. **TRUSTEES** – Ruling Elder Wayne Petersen, Chair

Wayne presented the following actions that were voted on and recommended by the Trustees:

Approved a grant of \$7,000 to Lee Vining Presbyterian Church in Lee Vining, CA for plumbing repairs

The Summerlin Mission Development Certificate funds held by the trustees with the Synod not be renewed, but transferred to the Demand Account also, held at Synod, and total of the funds be transferred to Grace Presbyterian Church in Las Vegas, NV

Approved Teaching Elder Dr. Ed Lockett as Chair of the Trustees and Ruling Elder Ray Bledsoe as Recording Clerk, for 2016, with expenses paid

The Trustees requested the Moderator of Presbytery appoint a Task Force comprised of a COM member, Mission Outreach member and a Trustee member to explore the options available to First Korean Church of Las Vegas and to extend making payments on the PILP loan through March 2016

Previous approval for making loan payments was through December 2015 by action taken by Council at the June 2015 meeting

Presbytery **VOTED** and **APPROVED** the requests and actions from the Trustees

5. **PRESBYTERY FINANCE – Ruling Elder Vern Manke**

Vern Manke, Director of Finance presented the following as recommended by the Trustees

The Ecclesiastical Budget proposed for 2016 shows income of \$104,119 plus the use of reserve funds of \$34,000 for a total of \$134,119 and expenses totaling \$134,119

Actions approved by the Presbytery as recommended by the Personnel Committee to fund the position of Presbytery Pastor to Pastors and increase the Stated Clerk hours and pay attributed to the need to budget reserved funds which are being held for these purposes

The per capita to remain \$35.00 per member for 2016

Tweaks (augmentation) of the 2015 budget included an increase in the Stated Clerk's pay of \$2,500 for the fourth quarter of 2015 and to include the pay and expenses for the Presbytery Pastor to Pastors for November and December  
[see Attachment B, budget reports]

The Mission Budget proposed for 2016 shows income of \$140,958 and expenses totaling \$126,987 resulting in a surplus of \$13,971

Tweaks (augmentation) of the 2015 budget included a \$2,000 mission grant through a General Assembly Missionary Mission to directly assist missionaries, The Rev. Barry and Mrs. Shelly Dawson who were guests of the Presbytery; a reduction of interest income from the Synod accounts held for Grace Presbyterian Church for the building fund, those funds are being transferred to Grace Presbyterian Church; and the grant of \$7,000 for plumbing repairs for the Community Presbyterian Church in Lee Vining, CA

Reported the Annual Financial Review had been received from Karen Stitt, CPA and was accepted by the Trustees [see Attachment 3]

Presbytery **VOTED** and **APPROVED** the reports and actions from the Trustees for Presbytery Finance
