

PRESBYTERY OF NEVADA, PCUSA

JOB DESCRIPTION

TITLE: Stated Clerk/General Presbyter

STATUS: Salaried, Exempt

PURPOSE:

The Stated Clerk/General Presbyter is an officer of the Presbytery, as required by the Book of Order, with judicial and ecclesiastical/administrative duties.

As Stated Clerk the Stated Clerk/General Presbyter is responsible for recording and maintaining records of all Presbytery transactions, preserving records, keeping rolls of membership and attendance, implementing pertinent governing body decisions, and performing functions specified in the Presbytery Administrative Manual.

As General Presbyter, the Stated Clerk/General Presbyter is responsible to assist the Committee on Ministry as requested, participate in the Synod and General Assembly Executive Forum and training, and making and receiving executive reference checks on behalf of the Presbytery and the Congregational PNC

ACCOUNTABILITY:

The Stated Clerk/General Presbyter is elected by Presbytery on nomination of the Personnel Committee. The Stated Clerk/General Presbyter is employed by the Presbytery of Nevada and supervised by Council through the Personnel Committee.

REPORTS TO: Presbytery of Nevada directly and through its Council.

JOB RESPONSIBILITIES AND TASKS:

I. Function: Rolls, Records, and Reports

A. Tasks

1. Process and record teaching elder calls, changes in terms of call, contracts, dissolutions, transfers, dismissals, and renunciations.

2. Prepare and/or receive, maintain, provide for safekeeping and/or distribution of minutes of the Presbytery, corporate papers, annual reports, reports to and from other governing bodies, and other historical documents pertinent to the life and history of the Presbytery. Maintain the following rolls:

a. Membership roles: Teaching Elders, Ruling Elders, Commissioners, Members, Corresponding Members, Pastors of new church developments, and Commissioned Ruling Elders

b. Attendance at Presbytery meetings shall be provided to the Nominating Committee and used in their recommendations

c. Former commissioners and Youth Advocate Advisory Delegates to the General Assembly and delegates to Synod, as well as rosters of church rotation for such commissioners, YAAD's and delegates. Candidates and inquirers

d. Roster and terms of current and former members of the Presbytery's Permanent Judicial Commission for the past eight (8) years

e. Agencies with formal relationships to the Presbytery

f. Churches, agencies, and special ministries of the Presbytery

3. Prepare and distribute current membership directories annually, including Teaching elders, Ruling Elder Commissioners, churches and their officers, councils, committees, and entities of the Presbytery

4. Oversee and secure Presbytery and congregational statistical reports to the General Assembly and Synod annually

5. Maintain the Presbytery reporting concerning Ministries and Pastors in transitions on the Church Leadership Connection

6. Assist PNC of congregations and session search committees in seeking Pastoral leadership

7.Oversee and maintain the online assets of the Presbytery Website directing the Presbytery web spinner in its content, security, and function

II. Function: Correspondence and Notices

A. Tasks

1. Receive, process, and report Presbytery correspondence received from higher more inclusive governing bodies.

III. Function: Meetings of the Presbytery

A. Tasks

1. In consultation with the Moderator of Presbytery obtain adequate facilities for stated and special meetings of the Presbytery, Council, and Trustees and, when needed, committees and/or commissions staffed by the Stated Clerk/General Presbyter. Serve as Clerk for meetings of the Council, which include preparation of the docket, notice of meeting, and minutes.

2. Help prepare a proposed docket for all stated and special meetings of the Presbytery and Council meetings

3. Issue notice of all stated and special meetings of the Presbytery at least ten (10) days in advance, in accordance with Robert's Rules of Order, to the Presbytery membership and Clerks of Sessions

4. Ensure the availability of the following documents and resources to be present at the Presbytery meetings:

a. minutes of the Presbytery for the previous two years,

b. copy of the Book of Order,

c. the Presbytery Administrative Manual,

d. Robert's Rules of Order, Newly Revised, and

e. the minutes of the most recent Synod of the Pacific meeting

5. Assist the Presbytery's Moderator during Presbytery meetings; determine and inform the moderator of a quorum

6. Provide for and communicate to the body as parliamentarian to serve during stated and special meetings
7. Prepare and deliver an annual necrology report to the Presbytery, Synod, and General Assembly and receive requests of all overtures and memorials to be addressed at the stated meeting by the Presbytery Pastor and resource the Presbytery Pastor when requested
8. Assist the Nominating Committee with the election of commissioners, delegates, and a YAAD during the Fall Presbytery meeting
9. Attend and resource the Committee on Ministry with voice but without vote.

IV. Function: Provide, Resource and/or Counsel

A. Task / Shall Respond to and/or Provided:

1. Ruling and Teaching Elders of the Presbytery, Presbytery officers, committee, and commission members regarding the Constitution of the Presbyterian Church (U.S.A.), the Presbytery Administrative Manual and Robert's Rules of Order; assist presbyters in understanding policies and actions of the Presbytery and its councils, committees, and commissions, as requested
2. The Committee on Bills and Overtures, the Permanent Judicial Commission, the Committee on Ministry, and administrative committees and commissions established by the Presbytery
3. The individual appointed by Equipping Ministries to conduct orientation of new Ruling Elder Commissioners and Teaching Elders to familiarize presbyters with the Presbytery's structure and enable full participation in Presbytery meetings, preparing and providing appropriate orientation materials as needed
4. Assurance that the Journal Clerk is supported by appropriate technology at Presbytery meeting venues
5. Supervise and resource annual Presbytery Records Review of Clerks of Session, usually coordinated with semi-annual Presbytery meetings

6. Training and support to Clerks of Session to ensure full understanding of their responsibility to follow the requirements of the Presbytery and Book of Order

7. PNCs and sessions seeking pastoral leadership

8. Presbytery's Permanent Judicial Commission and other Judicial Commissions

Evaluation:

An annual review and evaluation of the performance of the Stated Clerk/General Presbyter will be held during the fall meeting of the Presbytery of Nevada, or at another time mutually acceptable to the Personnel Committee and the Stated Clerk/General Presbyter
